ON-STREET PARKING AGREEMENT

On-street Permit Qualifications & Conditions:

1. All On-Street Parking Permits will be issued for residential properties only. The property may be owner or tenant occupied.
2. No more than one On-Street Parking Permit may be issued for any one building or tax lot regardless of the number of residential units contained in the building or on the lot. If the property is a condominium the application must include a resolution of the condominium association authorizing the application, in which case the permit will be issued to the association.
3. The property, because of its size or zoning regulations, or HPC standards, cannot physically be used for any off-street parking space. There must be a distance of no more than eight (8) feet from the property line to the home on each side and no rear access to the property. **An accurate survey of the property must be submitted by first time applicants with the agreement.**
4. The On-Street parking space will be issued in front of the property address, or, if there is no space at the property location, then at such other location as determined by the City.
5. The designated On-Street parking space is not otherwise prohibited, and the permitting thereof would not interfere with the normal flow of traffic.
6. The On-Street Parking Permit is valid May 1st through October 31st or January 1st through December 31st and shall be renewed each calendar year. **The cost of the May through October permit is \$350.00 and the cost of the January through December permit is \$500.00.** The issuance of an On-Street Parking Permit does not create a right with respect to any property for which the permit is issued. **The permit is Non-Transferable.**
7. A non-refundable application fee of twenty-five (\$25.00) dollars shall be paid at the time the application is filed. The applicant must include a photocopy of his/her valid driver's license, and a photocopy of the motor vehicle registration card for the vehicle to which the permit is issued. The application will be reviewed by the Police Chief (or designee) and the Zoning Officer.
8. If the application is approved, a permit fee is due before a permit is issued. The fee is subject to change and shall re-calculate annually each December 1st.
9. An authorized On-Street Parking Permit is to be hung on the rear view mirror of the vehicle identified in the application. Any applicant may change the designated vehicle one time during a calendar year by submitting a request form and photocopy of the vehicle registration card together with a \$25.00 processing fee to the City Clerk. **Failure to display the Permit will result in a traffic summons and court appearance.**
10. The City shall place signs at each reserved space identifying it as a reserved parking space, and subjecting violators to fines and towing.
