In 2017 Cape May City was awarded a Small Cities Home Rehabilitation Program in the amount of \$175,000 from the NJ Department of Community Affairs. Our program helps low to moderate income City homeowners to repair their homes. We can provide help with a wide variety of home repairs including those involving Heating, Electrical service, Plumbing, Weatherization Windows, Doors, Roofs, Foundations and other Structural Conditions.

The City is looking for new applicants to help.

Below are the current income ceilings based on household size:

Assistance is provided as a combination of a forgivable loan (50% of assistance) and deferred loan (50% of assistance). The forgivable loan converts to a grant in 6 years. The deferred loan is only paid back, without interest, when the homeowner sells their home.
