1 Notice is hereby given that the City of Cape May 643 Washington Street, Cape May, New Jersey  
2 08204 invites proposals for a single contract for the construction of a new headquarters for the  
3 Cape May Police Department to be located at the corner of Lafayette and St. John Streets, Cape  
4 May New Jersey 08204.

6 Proposals will be received at the Office of the City Clerk, 643 Washington Street, Cape May,  
7 New Jersey 08204, on September 9, 2025, at 11:00 (AM) local time, at which time they will be  
8 publicly opened and read aloud shortly thereafter. Bid Shall include one original and two (2)  
9 Copies, along with an electronic copy on a flash drive.

11 All bidders are strongly encouraged to attend, either in person or by representative, a pre-bid  
12 conference to be held August 6, 2025, at 643 Washington Street, Cape May, New Jersey 08204 at  
13 11:00 (AM) local time. All bidders shall be required to be familiar with the project site for this bid regardless  
14 of whether or not the bidder attended the pre-bid conference. It is recommended that all bidders attend  
15 the Pre-Bid Conference. At the time of the opening of Bids, each Bidder will be conclusively presumed to  
16 have inspected the site and to have read and to be thoroughly familiar with the Plans and Contract  
17 Documents. By submitting a Bid, the Bidder acknowledges that they have had the opportunity to ask  
18 questions, seek clarifications, and obtain any additional information necessary to prepare their proposal.  
19 No claims for additional compensation or time extensions will be entertained for unforeseen conditions or  
20 circumstances that the Bidder could have reasonably discovered through a diligent inspection of the site  
21 or review of the Contract Documents.

23 Bidders shall file bid security detailed in the Supplementary Instructions to Bidders contained in  
24 the Contract Documents.

26 The Successful bidder will be required to furnish a Performance Bond and Labor and Material  
27 Payment Bond in the amount of 100 percent of the contract price. Each bidder will be required  
28 to furnish additional evidence of performance security with each bid pursuant to N.J.S.A. 40A-  
29 11-16.

31 Pursuant to P.L. 1975, C.127 as amended, the Contractor agrees to comply with all provisions.

33 Pursuant to Chapter 33 of the New Jersey Laws of 1977, each bidder must submit with his bid, a  
34 Public Disclosure Information Statement.

35  
36 Bidders may obtain copies of Drawings, Project Manual/Specifications and Bidding Documents  
37 for this project after July 23, 2025, at the offices of the Architect, ROBBIE CONLEY,  
38 ARCHITECT, 596 Glassboro Road, Woodbury Heights, NJ 08097 upon Payment of **Fifty**  
39 Dollars (\$50.00) for the Electronic Documents. Additional copies may be purchased at the rate  
40 of **Fifty** Dollars (\$50.00) per additional disc, Paper Documents may be purchased for **Three**  
41 **Hundred Fifty** Dollars (\$350.00) for the first set. Additional sets may be purchased at the rate  
42 of **Three Hundred Fifty** Dollars (\$350.00) per additional set.
