

JUNE 2024 PROMENADE CRAFT SHOW

IMPORTANT INFORMATION:

- ALL JEWELRY VENDORS- Due to the limited number of vendor spaces for jewelers, all applications will be automatically
 waitlisted and reviewed by the Craft Committee. All accepted jewelry applications will be notified by email. Unfortunately,
 we will not be able to respond to all phone calls regarding the status of jewelry applications.
- 2. Event is rain or shine. Fee is non-refundable. You cannot transfer your space to another crafter.
- 3. This agreement shall be for a period of two days (see dates above).
- 4. All vendors must show proof of Insurance coverage.
- 5. Vendors must have weights and/or ties on their tents and umbrellas to sufficiently eliminate wind disruption and danger.
- 6. Set up prior to 7 AM is prohibited. Breakdown must be completed by 7 PM. Vendors who set up prior to 7 AM may be prohibited from participating in the show.
- 7. Vendor is fully responsible for set up. The City of Cape May does not provide tents, tables, chairs, linens, carts, etc.
- 8. All space assignments will be located on the promenade with space allotment of approximately 10 feet wide and not to extend outward into Promenade walkways. THIS WILL BE ENFORCED! Protective canopies cannot be larger than 10'x10' and their poles cannot extend out beyond the dimensions of the tent itself. All canopies may have to come down if the threat of damaging winds exists. Each exhibitor is encouraged to bring adequate chairs, free standing racks, and mounting equipment for their display.
- 9. Spaces have benches and arches, please be prepared to change your set-up to accommodate. Exhibitors are <u>not</u> permitted to move benches. Some exhibitors' spaces may be modified to create easier access for pedestrians on the promenade. Tents are **NOT** permitted to be set up in front of the benches or aches.
- 10. No deposits will be accepted. Payment must be paid in full to receive Promenade booth space(s). No one-day space assignments.
- 11. Only original work by the exhibitor will be accepted. **No kits or mass-produced items permitted**. If any imported, kits or mass-produced items are found in booth, exhibitor will be asked to remove items and future applications will not be accepted.
- 12. The City of Cape May reserves the right to remove any item deemed objectionable, unacceptable, or undesirable for any reason. The City of Cape May reserves the right to reject crafts that are not at the level of quality that the City deems suitable. All proceeds from craft sales go to the crafter.
- 13. The City of Cape May reserves the right to assign your booth space. In the event the crafter cannot occupy their spaces on the days of the craft show, the City of Cape May reserves the right to have those spaces occupied by other crafters. The City of Cape May reserves the right to remove and/or deny future application to any crafter who exhibits improper behavior toward craft show staff, patrons, and/or other crafters.
- 14. The City of Cape May will not be liable for any damages or injury to persons or property, sustained by conditions or activities on the premises. Vendors are liable for any damage occurring from their personal property.
- 15. Crafters are responsible for protecting their property and merchandise from damage or loss.
- 16. All crafters are responsible for the disposal of all boxes and packing materials. Do not leave materials on the promenade.
- 17. NO Food Accepted. This includes condiments and preserved food.
- 18. Smoking, alcoholic beverages, pets, loud music, gas, or electric powered generators are NOT permitted.
- 19. Parking Meters are in effect from 10 AM to 10 PM. Meters accept QUARTERS ONLY or sign up for Park Mobile at parkmobile.com.
- 20. Exhibitors must have a New Jersey Tax I.D.# Call 609-292-1730 NJ Div. of Taxation
- 21. Collection, reporting, and payment of New Jersey State Sales Tax is solely the responsibility of the vendor. The City of Cape May accepts no responsibility for sales tax collection.
- 22. A limited number of each media or craft will be accepted. Each craft item must be listed on your application.
- 23. Crafters MUST mail or e-mail photos of all types of the original works to be sold as well as a display photo to craftshows@capemaycity.com.
