ORDINANCE NO. 560-2025

**ORDINANCE AMENDING CHAPTER 7 OF THE CAPE MAY CITY CODE
REGARDING METERED PARKING
INCORPORATING THE AME CHURCH PARKING LOT**

WHEREAS, Chapter 7 of the Cape May Municipal Code governs vehicle and traffic regulations in the City of Cape May; and

WHEREAS, after review by the City Administration, the Cape May City Council desires to make amendments to incorporate the AME Church parking lot within the City's metered parking ordinances; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Cape May in the County of Cape May and State of New Jersey as follows:

SECTION 1. Chapter 7 of the Cape May City Code is hereby amended to include the following NEW SUBSECTION:

§ 7-45.10. Additional metered parking areas (Three hour limit).

Three Hour Time Limit Metered Parking April 1 to October 31

10:00 a.m. – 10:00 p.m.

\$0.25 per 10 minutes or \$1.50 per hour

NO OVERNIGHT PARKING PERMITTED AT ANY TIME

Name of Parking Area	Description and Location
AME Church Parking Lot	Block 1080, Lots 31 and known as 717 Franklin Street.

SECTION 2. All other ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency.

SECTION 3. Should any section, paragraph, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected thereby and shall remain in full force and effect, and to this end the provisions of this Ordinance are hereby declared to be severable.

SECTION 4. This Ordinance shall become effective 20 days after final passage and publication, according to law.


